3. Declaration of Members Interests

(a) A period of not more than 10 minutes will be made available for members of the public and Members of the Council to comment on any matter.

(b) If the Police Liaison Officer, a County Council or District Council Member is in attendance they will be given the opportunity to raise any relevant matter.

(c) Members declaring an interest other than a Disclosable Pecuniary Interest who wish to make representations or give evidence under the National Association of Local Councils' (NALC) Code of Conduct shall do so at this stage.

8. Discuss holding the proposed Outdoor Cinema on Friday 10th September 2021, subject to Government guidelines.

10. Discuss holding the proposed Christmas Market on Sunday 5th December 2021, subject to Government guidelines.
