#### 211022/9. Problems at any sites

Sandham Lane Allotment Association reported that they will be holding their AGM where they will review only accepting Ripley Township residents at their allotment. They are going to produce a tenancy agreement every year with rules for all tenants to sign and if they don't agree, they don't get a plot. They have recently had a problem with a plot holder having a bonfire out of the allotted time, breaking a lock not belonging to them and cutting a bush with wasn't theirs.

#### **NOTED**

Fearn Avenue Allotment Association reported that a residential neighbour to the allotments had a hedge taken down in July 2022 and they haven't replaced it with a fence yet.

**ACTION** Ripley Town Council to write to the resident asking them to put the fence back up due to lack of security on the allotments without it being there. If they don't replace it, Ripley Town Council will have the work done and recharge the resident for it.

#### 211022/10. Allotment Rents

The Deputy Clerk reported that all Allotment rents are paid for this year and that the rent of £30.00 per allotment association (£15 for Fearn Ave and £15 Pit Lane) will remain the same in 2023.
