# MINUTES OF NOVEMBER 20TH 2018 MEETING OF RIPLEY TOWN COUNCIL

held at 7.00pm in the Council Chamber, Town Hall, Ripley.

Prior to the start of the meeting, a minute's silence of respect was given for Maurice Gent, former Mayor of Ripley Town Council and Councillor Farrelly gave a eulogy.

## 201118/1 To Receive Apologies for Absence

Apologies for absence were received from Councillors Mrs. L. Joyes, M. Missett and M. Wilson.

#### 201118/4 Public Speaking

PCSO Dare reported on crime statistics for Ripley in October 2018. Theft x18, Criminal activity x11, Non-dwelling x4, Car theft x2, Burglary x1, Robbery x1, Anti-social behaviour x29 (includes the period when the fair was on and Halloween).

PCSO Dare said they Police were pleased with only 2 reported incidents whilst the fair was here. For the remembrance parade, five Specials and Police came in on their rest days to assist with the parade. PCSO Dare also spoke of projects they are working on with the local community:

Project Zao – Police going into schools to talk about anti-knife crime, to children aged 10 years and over.

Free Home security visits – to homes via online requests, (at present the request has to come via the online service) helping to make homes safe and offer advice on security. This will possibly be extended into the New Year.

First Contact Form – whilst going into people's homes and seeing they need advice in other areas, signposting people to other services like the Derbyshire Fire and Rescue Service or the Library Service.

Police and Crime Commissioner for Derbyshire has relaunched the Derbyshire Alert system which is a free community messaging service about local crimes and community events

Events – the Police will have a presence at the Ripley Christmas Light Switch on and the Christmas Market. 8<sup>th</sup> December they have a community stall on Ripley Market Place, 11<sup>th</sup> December, 10-12pm at Ripley Hospital and 19<sup>th</sup> December at Ripley Library where they will be giving safety and security advice.

Cllr Williams asked if the figures PCSO Dare reported were seeing increases / decreases in reported incidents or are they stable and was referred to www.police.uk for statistics.

Cllr Carter said he had used the 101 non-emergency telephone number and was pleased with the service, however he didn't hear the outcome of the incident he reported. PCSO Dare responded saying it depends on the type of incident. If an incident number was given, you can ring back and ask for feedback.

Cllr Jones stated his concerns that in Ripley is perceived as having ASB and residents don't feel safe in the late afternoons and evenings. He asked what can be done if we see people that aren't actually committing a crime, but look like they have or will. The Police responded saying people should ring 101 with information.

Cllr Cutting thanked the Police for communicating more with the public through the Derbyshire Alert System.

Cllr Mrs. S. Emmas-Williams reported that some Ripley Town Councillors recently attended the Neighbourhood Watch AGM where it was reported that Police community engagement had reduced. The Derbyshire Alert System was relaunched, and she encouraged everyone to register for the alerts also giving her appreciation to the Police for attending this meeting and proposed that RTC write to Derbyshire Police asking them to continue attending Council meetings.

**RESOLVED:** Ripley Town Council write to thank the Chief Constable of Derbyshire Police for the new initiatives which are welcomed, however, there is concern that the Police attendance at Ripley Town Council meetings is irregular. Also to state it would be beneficial to all to see more Police Officers in the Derbyshire Constabulary.

## 201118/12 Ripley Town Council draft budget 2019/20

Cllr Freeborn proposed that there be no increase in the Ripley Town Council section of Council Tax in 2019-2020. The Christmas Lights are a significant cost and residents should be delighted with this proposed budget. Ripley Town Council have given more money to local groups and the Environment Committee now has a budget of its own to identify needs and results within the Township. RTC are also making significant contributions back into the reserves. The draft budget is subject to consultation with the public and we ask for comments by 4<sup>th</sup> January 2019.

Cllr Fisher seconded the proposal of the draft budget. He reported that Ripley Town Council also fund the Citizens Advice Bureau weekly advice sessions, and has plans to expand the provision for young people in 2019. Further the Town Council put on several events throughout the year for residents to enjoy including the Christmas Lights switch on, Christmas Market, Spring and Harvest festivals plus the Big Day Out.

**RESOLVED:** Ripley Town Council unanimously accepted the proposal and there will be no increase to the Ripley Town Council part of Council Tax for 2019-2020.
