## 200421/14. Oxford Street Barrier update

Cllr Freeborn spoke of his disappointment that the Ripley SNT team haven't been able to attend this meeting to give a report on the number of tickets issues to vehicles on Oxford Street during restricted hours.

**RESOLVED** The Clerk writes to Inspector Paul Stevenson to seek information about ticketing and the number of cars being trapped on Oxford Street since the barriers were reinstalled.

## 200421/15. Greenwich Park - update

Cllr Freeborn reported that Ripley Town Council would still very much like to have responsibility for Greenwich Park, along with Greenwich Park Sports Partnership, however it is yet to be arranged by Amber Valley Borough Council. AVBC Cabinet met in March 2021 where they had a report stating that they no longer owned the land. This is not the case as the transfer to Ripley Town Council still has not happened. Unfortunately, Officers at AVBC have chosen to mislead the public and Councillors.

Cllr Fisher reported that things are changing with restrictions being eased. The Clerk and Deputy Clerk are negotiating with Blend and Amber Valley School Sports Partnership regarding a youth programme to start during the May and summer school holidays. We are hoping to re-establish the Wednesday night Youth Hub from the end of May 2021 to all young people in the township and villages.

She also reported that for the Outdoor Cinema in September 2021, we will again consult with the community and let them decide which film they would like to watch from a list of five that we collate.
